



Re: Case reference: LH29N.315183 Lands to the east of Saint Paul's College, Sybil Hill Road, Raheny Dublin 5 (LRD6002/22S3)

A Chara,

I wish to make an observation in relation to the above planning appeal submitted in relation to a residential development on park lands to the east of St. Paul's College, Sybil Hill Road, at St. Anne's Park, Raheny, Dublin 5. To this end, I enclose the requisite fee of €50.

I object in the strongest possible terms to the proposal to build 580 residential units of up to 7 storeys high on the St Paul's Playing Fields at St Anne's.

This, as your aware, in the latest in a series of planning applications made in relation to these lands going back to 2015. The High Court in it's decision of 7 May 2021 made an emphatic judgement in relation to this site. It rejected any development on this site on several grounds. This case establishes a precedent for any subsequent similar planning application such as the current appeal.

It is vital that this judgement of the High Court is respected. In a common law jurisdiction such as ours, case law decisions of the courts form part of our legislative system.

The potential impact to the Dublin Bay biodiversity is significant. As set out in the High Court decision, St. Anne's Park is the closest site utilised by birds that are qualifying interest for the purpose of the North Bull island special protection area (SPA) (004006).

We need to preserve our public parks and maintain a quality of life for all the users of the park. This is not just for now, but for the future.
