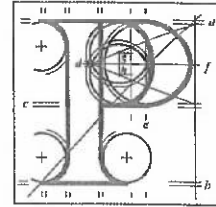

Niamh,

I refer to ABP's correspondence to the planning office dated 16th March relating to the SID application application lodged with the Board for the wind energy development of 19 no. turbines at Clogherachullion, Clogheracor, Derryloaghan, Aghayeevoge, Cashelreagh Glebe, Darney, Drumard and Drumnacross, Co. Donegal, seeking a report under S.37E (4) PDA setting out the views of the planning authority on the effects of the proposed development on the environment and the proper planning and sustainable development of the area.

S.37E (5) requires that prior to submission of the report to ABP that it is first submitted to the members of the Council to seek the views of the members on the proposed development the report; unfortunately there was no Pleanary Council meeting in April with the next Council meeting not being held until the 29th May. I hereby request that the deadline for the submission be extended for a period of 2 weeks from the 18th May to the 1st June to allow for the views of the Council's members to be included in the report.
