

## To An Board Pleanála

We Breda & Pat Curran, are the property owners of [409 Landen Road, Ballyfermot] are writing to An Board Pleanála to submit an observation in relation to Substratum land acquired for Dart + South West, Reference No: 18832.S59(A). CIE proposed works for Dart + South West being carried out under our property (Substratum) and over the boundary wall which is approximately 12ft from our existing property.

The report assessment states vibration and noise disturbance due to the carry out of infrastructure/construction such as retaining wall, and ground anchors running under our property and removing the bridge and assembling a new bridge on Kylmore Road. Dart + South West Assessment reports working hours for this project states, Monday to Friday: 10 hours: from 08:00 to 18:00 and weekend through the night until the early hours of the morning. All of which says in the report that there will be large volume haulage and deliveries and weekends, all of which states "potential for significant noise impacts during site clearance, ground investigation, earth works, piling, soil anchoring as well as track lowering and bridge construction". A corridor gap of nearly 2 meters approximately between the existing boundary wall and the retaining wall.

## **Impact**

As a professional Social Care Practitioner working 24-hour shifts during the week and weekends. I believe it would be impossible for me to sleep and rest in my home and would be detrimental to my overall mental health and wellbeing. Also, this would have an overall negative effect on our family in terms of having a right to a quite enjoyment of our property. As our kitchen extension is only 12 feet from the existing boundary wall where construction/infrastructure will be carried out.

We have deep concern and fear for our security to the gap of nearly 2 meters approximately between the existing boundary wall and the retaining wall. This creates an easy assessable route to the back entrance of the property.

In a community whereby the crime rate is high i.e., drugs, addiction and anti-social behaviour we would be in fear of our security and safety in our home. When the team and engineer from CIE called to our home, they didn't seem to see this as an issue which caused me to worry about their project. I have lived on Landen Road, Ballyfermot for over 30 years in all this time CIE have never clean or cut overgrown hedging until this February were there was an unsuccessful attempt that made no difference to be honest. CIE have never reached out to the me over the years with any quality assurance or working relations except putting leaflets in my door to say they are carrying out weekend work from 12 to 6am.

I would have deep concerns and worry around Substratum land being acquired whereby CIE want to acquire our Substratum land to drill wall anchors under our property to provide stability to a new retaining wall. My concern would be damage to property with a focus on our 25ft kitchen which is 12 feet away from the boundary wall. If An Board Pleanála grants the proposed Dart + South West. I would certainly like to obtain legal guarantee in writing that there will be no damage done to our property during Contruction being carried out now or in the future to come. The taking down of Kylmore road bridge will cause traffic disturbance for the community and personally for my family going out and coming home especially morning and evening times due to having to take detours this will put extra hours to our journey to work and back.

What is the responsibility of CIE when vermin (rats and mise) are disturbed from their natural habitat. This poses a health and safety risk to our home as we may have to keep all the windows and door closed to the back of the house. I will be seeking compensation due to the massive impact, disturbance, and other unforeseen circumstances i.e., such as the health hazard, dust, we as a family will have to prepare for and suffer when this happens.
