

Submission on DART+ South West Electrified Railway Order 2023

To Whom It May Concern,

I wish to submit an observation concerning the draft railway order for the proposed DART+ South West project. As a member of the Seven Oaks Management Company I am referenced in the railway order.

The planned works include the reconstruction of the Khyber Pass footbridge (works no. 12.27), along with the establishment of a construction compound in a temporarily occupied site on the south west corner of Seven Oaks (works no. 12.28). The construction compound would be accessed via the Khyber Pass laneway which runs directly alongside Seven Oaks blocks A, B, and C. I understand that these works will continue for several months and will produce significant noise, some of it during night-time hours. I am concerned about the impact of this noise as I work from home in my apartment at Seven Oaks and four of my windows directly overlook the Khyber pass laneway.

I note that the proposed project does not provide for the construction of any new stations between the existing station at Park West / Cherry Orchard and the proposed new station at Heuston West. This means that despite the disruption caused by the construction works and subsequent operational noise from the increased number of trains, the closest station will continue to be at Heuston, some 3km away.
