
I am enclosing both letters.

I refer to a Railway Order submitted by CIE in respect of DART+ South West Project.

I received a letter dated 16th March 2023 informing me of the proposed works to the railway line behind my house, as I am directly affected by this.

My name is Helen Fayne and my address is 2 Claremont Lawn, Glasnevin, Dublin 11, D11 Y8PF.

My home is directly affected by this project and I wish to submit a SID observation in respect to this project.

My home backs onto the railway line so right behind my back garden is the rail way line where a number of the works will be taking place including the acquiring of Substratum land quantity 27.7 sq m.

I have severe reservations on this project and the effect it will have on myself and my family. I object to land being taken even if it is underground land. I object to the noise associated with this work.

My reservations as follows:

- I am concerned that 27.7 sq m is proposed to be taken from under my garden, and any impacts this has to my garden now and in future years to come. For example in ten years time, will the ground subside or cave in at any stage. Any guarantees that this will never happen and there will never be any associated risks.
- I am concerned on the noise levels and vibration levels. At the moment we have been told that the entire project is 4 years and minimum 5 weeks of this will be on the rail way line behind my home in order to insert pipes etc underneath the gardens. The noise from this will be severe whether it be in the day time or night time it will be extremely difficult to maintain a normal life with working from home, sleeping, napping, enjoying the garden during the day & evenings, having family and friends over and have my children and their friends out playing in the garden.

- I have 8 year old twins and they play in the garden most days when the weather is good and when the works are going on this will hamper their enjoyment of the garden. We have pets who also spend a lot of time in the garden and the noise will terrify them and deter them from going out to the garden.
- There are 3 adults in the home who all work from home a number of days a week and the noise levels will hinder this and make it extremely difficult to work from home—concentration levels trying to work on our laptops and then we will prob be unable to take phone calls or attend virtual meetings with the noise levels.
- There is an extension in my garden (little granny flat) and it is rented out and I am
 concerned with the noise levels it could impact on keeping the current tenant and/or
 getting a new tenant so we may get reduced rent or no rent for length of time there is
 noise and disturbances
- Even when the works directly behind my home is finished, there will be works on the bridge leading into the cemetery and in the car park of the cemetery. The car park is to be used as a depot. We are two houses down from the car park and v near the bridge so the noise levels and disturbance from this will severely impact on us as I understand the works here will take a lot longer, although I don't have the time-frame. The works here will also impact on us working from home, sleeping, napping and enjoying our garden.
- In addition to the noise on the railway line and bridge, we will be affected by the additional vehicles, workers, machinery going into the cemetery to do works on the bridge more traffic on our estate, workers will park on our estate general increase in traffic up and down our little estate. Safety issue will arise for the kids on the estate when they are crossing the road to go to the green area.
- When the project is complete, we will now have darts operating on the railway line so the noise from this every 5 10 mins from early morning to late and over weekends will impact on us severely. Currently it is mainly goods trains and few commuter trains which use this line and are not that frequent and very infrequent over weekends so the amount of trains now using the lines will increase substantially 7 days a week from early to late, we will have the constant whizzing noise.
- Impact of rodent infestation behind my garden on the banks of the railway line are
 hedging, bushes, trees, briars etc and are home to rats and mice so presumable some
 or all of this shrubbery will be removed during the project and presumably these
 rodents will infest our gardens and homes when the bushes etc are removed or even
 from the noise they will infest our gardens and homes for solace
- The value of my home will be impacted presumably the home values will go down
 as nobody will want to purchase homes with railway works ongoing behind their
 garden and even when finished, there will always be concern that the underground
 under the garden is owned by CIE and possible concern over subsiding.

- Potential buyers will also be reluctant to buy property backing onto a busy railway
 line with constant noise and vibrations from darts all day long 7 days a week so we
 may never be able to sell the property, find it very hard to sell or get a low value on
 the sale because of this
- Lastly, I am concerned of possibility that the construction vibrations or vibrations from the darts could damage the structure of my property either at time of works or over time in years to come.

I am disappointed that as I am "lay person" - i have no understanding of these applications, dealings with The board, putting in observations/ objections etc, i was relying on your good selves and your 3 colleagues who met me to inform me of these matters.

When i specifically asked the three people who met me if I needed to pay the 50euro, i was told no. Surely one of them would have known what you stated below - once you submit the application to the board the names cannot be changed.

That really disappoints me.

I am also disappointed that you will not approach The Board to amend the Book of Reference and you are waiting for an oral hearing which may or may not happen.

Firstly, please accept our sincere apologies for not being able to get back to you sooner.

We acknowledge that the DART+ South West Project Team members met with you and your husband at your home at your request on 2rd May 2023, when you advised that while the property remains in your mother's name on the Property Register Authority of Ireland (<u>PRAI ie</u>), she is deceased and your family live there now. The project property records have since been updated and the project team will correspond with yourself going forward regarding 2 Claremont Lawn, Glasnevin, Dublin 11.

The meeting with you was requested and held after the application for a Railway Order was submitted to An Bord Pleanála ("the Board"). The information provided to the Board could not be adjusted after the application was submitted.

My name is Helen Fayne and I am residing at 2 Claremont Lawn, Glasnevin, Dublin 11. D11Y8PF

My deceased mum Breeda Fayne received a letter dated 16th March 2023 regarding CIEs intent to submit an application to An Bord Pleanala for a railway order in respect of this project. Reference on letter LO-224

Breeda Fayne passed away in 2014 and I moved into this residence in 2015 with my husband and twin girls.

I submitted an observation to An Bord Pleanala prior to the 16th May deadline. I did not submit the 50euro fee as I was informed that due to me and my residence being directly affected that I did not need to submit this fee.

I received a letter last week from An Bord Pleanala informing me that my submission cannot be considered and has been returned to me due to the fact that I did not enclose the 50e and my name is not on the schedule they received from you.

On 2nd May this year, 3 representatives from your office called to my residence at address above to meet with myself and my husband.

We requested this meeting to discuss our concerns about the works and about fact that part of underground of our garden is needed for these works.

I did not get their names but it was two men and a woman. One of the men was an engineer and the other man was on the CPO side. The woman done most of the speaking with us and she was the person who told me to send my observation submission to An Bord Pleanala and that I did not need to enclose the 50euro fee with my submission as my property was directly effected by these works.

I mentioned to these three individuals that my mum Breeda is deceased and I gave my name Helen Fayne and I also gave my husbands name Charles Ryan as currently residing here. One of the individuals wrote this into a notebook.

None of these three individuals indicated to me that there would be any issue with me submitted my observation to An Bord Pleanala and I am now very disappointed that An Bord Pleanala have rejected my submission due to the incorrect name in the schedule

I have today spoken to Eimear Reilly in An Bord Pleanala. Eimear has informed me that the schedule needs to be amended by yourselves to refer to my name instead of my deceased mum Breeda. Then the amended schedule needs to be re-submitted to Eimear and I may then be able to re-submit my observation.
