

Subject: Railway Order observation for DART South West

Hi there.

My home will be impacted by the proposed DART South West project (Referenced in the Railway Order) and I would like to make observations as follows.

I live in the Seven Oaks apartment complex, Sarsfield Road, with my apartment facing on to the existing railway line. My bedroom window and living room balcony door & balcony all face directly on to the railway line. I stand to face years of construction noise, followed by increased operational noise associated with the expansion of the number of lines from 2 to 4 and increased volume of train traffic.

As a condition of this project going ahead I would like to see funding provided to impacted householders such as myself to install noise mitigation measures, such as acoustic glass and / or secondary glazing. This would go some way to offsetting the noise impact and reduced quality of life that I stand to suffer if this project goes ahead.

Since there is no new station planned for Inchicore as part of this project, I stand to be impacted by the project but see no benefit whatsoever. The expansion of the number of lines beside by home may negatively impact the value of my home, potentially by tens of thousands of euro. I would like some consideration be given to this matter. In particular a new station at Inchicore would allow impacted householders such as myself enjoy the benefits of the new lines, and may offset the decrease in value of my property. Alternatively, compensation should be considered.

Finally, I do question the need for this project at all post-covid. We now have a working from home culture which has reduced commuter usage of train services and the this may invalidate the original business case.

Please take my views expressed above into consideration as part of the planning application.
