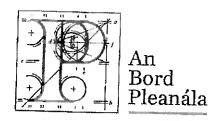

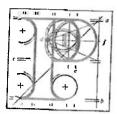

This project aims to enhance transportation infrastructure and connectivity, addressing the growing needs of the county and country. Ultimately, it leaves densely populated Lower Ballyfermot, perhaps the most directly affected, completely out. While the intention behind the application seems commendable if not looking too closely, it is crucial to consider the potential impacts on the directly affected community, environment, and existing infrastructure.

Community

Ballyfermot Train Station

It is not acceptable that a local train station is merely verbally accepted. Online and physically distributed plans must show clearly that Kylemore Station will be finalised during the earliest possible stage of construction.

Accessibility

This is a densely populated area, and we are underserved by public transport. There are many elderly and young people with special needs as well as families with buggies who would be much better served by a train than a bus¹.

Environment

The frequency of trains kicking up dust and dirt will absolutely affect the air quality.

Duration of works has not been accurately estimated. Having been resident in this house for 4.5 years, I know heavy works happen primarily throughout the night. The prospect of

ongoing works 24/7 for an indeterminate time will make living in this house very difficult - months? Years?

Several negative implications should be considered. Firstly, noise pollution disrupts the tranquillity and peacefulness of the residential environment, affecting the ability to rest, relax, and carry out daily activities without disturbance. I was unable to attach the videos I had made to provide as evidence here, but train-related noise is ongoing as it is and it can be very difficult to tune out sometimes. High-pitch idling is a horrible sound and it sometimes goes on for 3-4 hours.

Secondly, transport-related noise pollution poses potential health risks. Prolonged exposure to excessive noise levels can lead to increased stress levels and sleep disturbances. It may also contribute to elevated blood pressure and cardiovascular problems among individuals exposed to prolonged noise pollution². Disturbance during the night when residents are trying to sleep is not a matter to dismiss. Many of us have young children (ours just 11 months old) whose bedrooms face the train tracks, and the entire family's health and wellbeing depends on their undisturbed rest. What assurances to buffer noise can be provided?

Furthermore, the noise pollution negatively impacts the overall livability and desirability of the affected area. It can deter potential homebuyers, leading to a decline in property values and hindering local economic development. It also hampers the enjoyment of outdoor spaces, such as gardens, as the noise disrupts peaceful recreation and social activities.

Pest Control

It is well known that rats and other "pests" live around the trees and walls currently in place. I request that a well thought out pest control plan is in place before any work commences. This includes guidance and if needed, financial support to affected residents.

 - Again, that is much more attractive and holistically beneficial
- Privacy

Anchors

I have been made aware that the anchors will be 2 meters below the retaining wall and will continue in a downward direction when going towards peoples properties, and that they can go down as far as 10 meters. If planning permission is granted, and funding is allocated etc, I will be seeking the list of contractors Irish Rail are to provide to have a survey conducted on our property before any works start "in the unlikely case that any damage happens to any properties."

I am also concerned about future damage - we can already feel a bit of a shake from the power of the current trains passing as they do - what damage could come from high speed trains passing with extreme frequency over time? Say 10, 20 years?

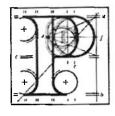
