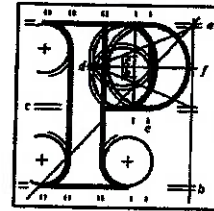

355 Kylemore has 3 adult occupants & a baby now aged one.

1. Concerns regarding structure of my home including front and back gardens/shed, patio & driveway during works.
2. Noise disturbance when working from home/sleep-rest disturbance at all other times, windows/patio doors in house will have to be closed due to dust and debris during works-therefore effecting ventilation during summer months when temperatures are normally higher.
3. Driveway access-will we be able to park our car in our existing driveway? My son is a mechanic and has large heavy tools which he has to take to/from his car everyday. Will there be a secure alternative parking option given to him if we cannot access our existing sideway?
4. Privacy to front of house during works.
5. How will this effect bin collections, deliveries, utility providers, tradesmen being able to access our property for any maintenance work etc?
Where can they park?
6. I have concerns about how the works, in particular the vibrations and noise will effect our dog who is normally in our back garden while we are at work mon-fri.
7. Pest control during works-the control of infestation of rodents.
8. Will we lose access to water, gas, electricity & wifi during works.
9. Effect if the appearance of the front of my house, regarding dust/dirt on paintwork, windows & doors.
