



To whom it concerns

I would like to submit an observation in regard to the Dart+South West Railway Order development.

I am a resident of Kilmainanham SQ Dublin 8, of which the development will be right beside and behind.

Whilst I understand its importance of the development. I have some important and worrying concerns that I would like addressed.

Primarily I understand that the majority if this construction work will probably take place at night time. As I live adjacent to the actual train lines this is a very worrying issue for me. I and my partner like most people work daytime hours. And I fear that the construction works will severely impact on my ability to sleep during its duration and by extension ability to function normally on a daily basis as a result of lack of sleep. I would like to know what proposals if any the development has to minimise or exclude or buffer the amount of noise at night time hours?

I understand testing has been done in the complex at certain times, but also understand that sampling was poor. Only 3 apartments were sampled, including a 9th floor which is furthest away from the actual area of construction. I am on the second floor which is basically the closest.

I understand Vibration testing was carried out - and again sampling was poor. Nothing below 3rd floor level. It states that there will be no material vibration impact during vibration. I live on the second floor so clearly this is not sufficient or accurate given I can confirm the vibrations that do occur on a regular basis form trains that do pass during the day (and am willing to let my apt be used to sample said vibrations)

Furthermore there has been no information around mitigation to potential damage of the building

As I have asked in my initial query, I understand no detailed design or information around noise and air pollution mitigation has been offered.

	It is deeply worrying that the concerns of I and other residents of the complex should succumb to a very small and clearly inaccurate sample size. It is also even more grave that the results of that sample size could lead to a major disruption in standard of living for myself and many more without any proposed mitigation that would seem sufficient.
