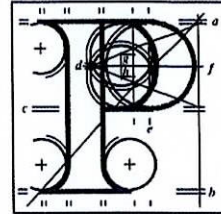

Sarah,

In relation to your correspondence of 22nd June enclosing the additional observation from the DAU, we note that the same date of 18th July is mentioned in relation to responding to this new observation.

The detail of the DAU letter is such that we would need more time to properly consider the points raised. We also assume that it would be preferable for ABP to have one combined response rather than two separate responses? For that reason, could I suggest that a combined response date of four weeks from receipt of the DAU observation be set as the response date? We received the DAU letter on 29th June, so we would request that a new response date of Thursday 27th July be set for the combined response.
