

To whom it may concern:

I am a landowner with land on the L6612, which stretches from Carraun, Co. Sligo, to the locally known Carra School. My land is on the haul route for the construction phase of the proposed windfarm development and hydrogen plant. The interconnector/electrical cables route is also proposed along this road.

At no stage have I been consulted by the applicant in relation to my land being used for passing bays, road widening, interconnector route or road closures.

I am very concerned about my family home, animal welfare, agricultural land and livelihood. I am also concerned about the inconvenience that would be imposed on me for almost two years, if this proposed development goes ahead.

I resent the way it has been stated in the plans that third party lands are required on this route when there has been no prior engagement with me at all. (Chapter 15, Traffic and Transport, 15.4.3. page 54)

I am totally opposed to this project for reasons stated.
