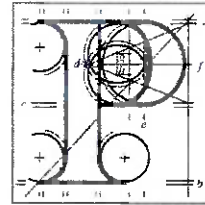

**Proposed Coolglass Windfarm and related works**

Dear Sir/Madam,

We, Dermot Cooney and Margaret Devoy write in connection with the abovementioned planning application. As a long-term resident with property at the centre of the planned wind farm, I wish to object to the proposed development by Statkraft.

Our principal concern is that our property, which includes a series of historic farm buildings (elements of a rural upland settlement), located in a mature tranquil woodland setting and at which we intend to establish our counselling and therapy business, is located less than 240-Meters from the proposed location of Turbine No.7 in the above application.

The development of the proposed wind farm, should it proceed, would have a detrimental impact on the value of our property and on our ability to establish and maintain our business.

We respectfully urge that planning permission for this development be refused.
