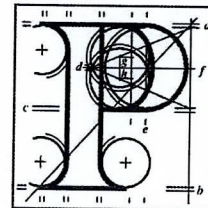

Dear Sirs

I have been consulted by Pat Whelan of Milchem, Tynagh, Loughrea, Co. Galway who has instructed me to lodge an objection on his behalf to the above mentioned application.

His objection is based on the following grounds;

1. The proposed development will increase the water flow to my clients lands and could possibly cause considerable flooding.
2. The proposed development will cause considerable dust on my clients dwellinghouse and lands which will be injurious to his health and to the health of his livestock.
3. The existing power station causes considerable noise which also has an adverse effect on the health of my client and livestock. There is no doubt but that the noise level will increase considerably if this development proceeds.
