

I have been consulted by Ralph Conroy of Tynagh, Loughrea, Co. Galway who has instructed me to lodge an objection on his behalf to the above mentioned application. His objection is based on the following grounds;

1. My client carries on the business of training and breeding of horses for showjumping and eventing. He specialises in high quality animals which perform on the international stage. The noise which will emanate from the proposed development will cause massive problems for his business and could possibly mean that his business will not be able to operate even on a restricted scale.
2. Apart from the noise aspect the proposed development will cause considerable problems on my clients animals. Horses of this type are extremely sensitive and the development has the potential to create an animal welfare issue.
