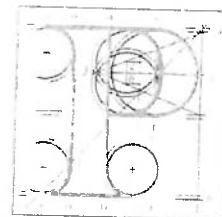

Dear Sir / Madam,

An Bord Pleanála has received the additional information requested by it in relation to the above-mentioned proposed development. As the Board considers that this additional information contains significant additional data in relation to the likely effects on the environment of the proposed road development and the likely consequences for proper planning and sustainable development in the area in which it is proposed to situate the said road development it hereby requires you in accordance with section 217B(7) of the Planning and Development Act, 2000, as amended, to -

(a) publish in one or more newspapers circulating in the area in which the proposed development would take place a notice stating that significant additional information in relation to the said effects has been furnished to the Board, that the additional information will be available, for inspection or for purchase (on payment of a specified fee not exceeding the reasonable cost of making a copy), at a specified place and at specified times during a specified period, and that submissions or observations in relation to the additional information may be made in writing to the Board before a specified date, and

(b) send a notice of the furnishing to the Board of significant additional information, and a copy of the additional information, to the bodies and persons referred to in section 217B(7)(b) of the Planning and Development Act, 2000, as amended, to indicate to such bodies and persons that submissions or observations in relation to the additional information may be made in writing to the Board before a specified date.

In respect of (a) above the notices should be published in the same newspapers in which notices of the original application were advertised and the additional information should be made available for inspection or purchase at the same locations at which the original application documentation was available. In respect of the time limits for the making of submissions or observations in relation to the additional information to the Board under (a) and (b) above please indicate the specified time limit for the receipt of submissions to be not less than 30 days in both cases.

You should submit the relevant newspaper notices and a copy of any notices issued under (b) above to the Board as soon as same are available.


