I tried to call on Friday, and I'll try again later today to discuss the below, but I just wanted to send this on to you in the meantime in the interest of time.

As you know, Galway County Council submitted 2 Responses Documents to An Coimisiún Pleanála on 24 October 2025 in relation to case references ABP-318217-23 and ABP-318220-23.

We just noticed after the Responses Documents had been submitted that there were some minor formatting issues with a number of cross-references in the Response Documents which occurred when the documents were being compiled, where for instance the document mistakenly referred to Section 0 instead of the relevant section in the document. These formatting issues may make both Response Documents a little bit more difficult to follow in some places, and so we have prepared the attached clean versions of both the Response Documents with these formatting issues corrected. There are 9 such formatting issues in the ABP-318217-23 Response Document and 26 in the ABP-318220-23 Response Document. For completeness, we are also forwarding tracked changes redlined versions of the updated Response Documents against those versions previously submitted so that An Coimisiún Pleanála can readily see the small number of formatting issues that have now been resolved in the attached updated versions.

Please use the clean versions of the Response Documents attached to this email in lieu of the versions submitted on 24 October.
