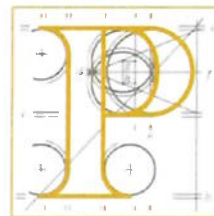

This following is my submission based on the proposed Coumnagappul Wind Farm for the following reasons:

Violation of County Development Plan: The location is designated as a "no-go" area for wind farms in the county development plan. Erecting the wind farm in this region directly contravenes established planning guidelines and the county development plan.

Environmental Impact on Biodiversity: The project poses a severe threat to the biodiversity of the uplands. The ecosystem, flora, and fauna in the area will be adversely affected, leading to irreversible damage to the local environment.
