Dear Mr. McGettigan,

Thank you for your letter of the 25<sup>th</sup> September 2025 regarding the additional information provided to An Coimisiún Pleanála in relation to the likely effects on the environment of the above proposed development.

In accordance with the directions of the Commission and sub-section 2(b) of 37F of the Planning and Development Act, 2000, as amended, Indaver NV t/a Indaver Ireland has taken the following actions:

- (a) The publication in three newspapers, (the Irish Independent, the Irish Examiner and the Echo respectively) on the 6<sup>th</sup> October 2025 of notices stating that significant additional information in relation to the said effects has been furnished to An Coimisiún Pleanála on the 29<sup>th</sup> August 2025.
