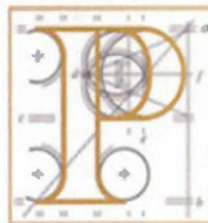

The Inspector will have already read this information and normally they do not need to receive this information again. Any legal submissions must be part of the substantive submissions to the hearing.
- Where similar issues are raised by a number of observers, the Inspector will not allow undue repetition. Joint submissions will be welcomed in the interests of efficiency.
- You should consider in advance what questions you might wish to pose in relation to the aviation related issues as specified.
- Having regard to the Limited Agenda and the specified matters there is no requirement for closing submissions unless requested. No new points, issues or legal matters can be raised in the closing submissions.
- This Limited Agenda Oral Hearing will be recorded by a service provider organised by An Coimisiún Pleanála. You are not permitted to record the proceedings of the Hearing.


## What happens next?
