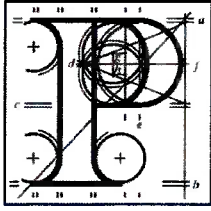

A large part of NCE's business comprises providing planned & emergency services to ESB, comprising trenching & ducting works for LV/MV & HV projects. It's essential that these works are carried out strictly in accordance with ESB & DCC Highways specifications, hence our supply chain is vetted to ensure the quality of materials is in accordance with ESB/DCC specifications. As such, Hudson Bros are a critical supplier to NCE, and they are one of the few suppliers who can provide materials which are in accordance with specification. If it ever became the case that Hudson we're no longer able to provide such materials, the impact of this on NCE, ESB & DCC, would be significant. Furthermore, there would be an increased detrimental impact on traffic and all road-users, as the public realm roadworks required to undertake our service to ESB cannot be done without causing disruption (which we take every measure to mitigate against). However, losing a critical supplier of ESB approved materials would undoubtedly exacerbate traffic disruptions, particularly during rush-hours.
