I am writing to object vigorously to the granting of Planning Permission to the above application. The impact of this application on my life, my home and farm is a horrendous intrusion and worry.

For many a year now we have been experiencing the impact of the blasting, the vibrations, cracking noise in the house, the movement of pictures on the walls and the vibration on the floor is not a very nice experience. We then have the crushing process to contend with. This crushing causes Quarry dust from rock crushing. Quarry dust is from Rock Crushing which is a by product of the crushing process which is a concentrated material to use as aggregates for concreting purposes especially as fine aggregates.

Research has shown that these large particles of dust, larger than 30  $\mu$ m will be dispersed within 100 metres of source, intermediate sized particles 10-30  $\mu$ m, are likely to travel 200-500 metres. I live approximately 240 metres of boundary. Rock crushing creates invisible dust which contains

microscopic solids or liquid droplets that are small enough to get deep into the lungs and cause Silicosis a progressive lung disease. Long term exposure is strongly associated with heart disease, stroke, infertility and pregnancy complications. This affects all age groups young and old, people residing close to Quarry sites, which we are, have a higher prevalence of respiratory symptoms compared to those not exposed to quarry dust. So whatever method is used it is horrendous and has no regard for the people in the area of close proximity. Air Pollution is a very serious <sup>invasion</sup> of my air space and surrounding houses. This is what we are living with from this quarry. Quarry Toxicity is deadly. The farm animals are also exposed to the same conditions. These animals end up in the food chain. The wells and septic tanks have to be considered also.

The damage to the landscape and visual impact will significantly change the overall view and will have a negative impact on the landscape in this highly sensitive Protected area of Kildare (East) up lands Scenic area which needs to be protected. As it stands it has lost a lot of its beauty and wild life even the water hens on the Pond at the bottom of this field. This field was also used for the making of the film Hear my Song which was about Joseph <sup>the</sup> famous Irish Tenor.

There is no special need for this quarry to be extended into Athgarnett taking more much needed agricultural land to disappear into another big terrible pit. Enough agricultural land has been



destroyed already. What are these pits going to be filled in with?

This field also borders Glending Wood. A very popular walking area for the locals of Ederburn, Blessington and other areas. Delightful to walk in but not with the cluttering and bonding of the pit.

Glending: Outline Site Description - a dry glacial channel.

Geological System / age and Primary / Rock Type: - Quaternary (Pleistocene) glacial till cutting into Silurian greywackes and shale

Geomorphological Interest: - This glacial spillway displays a pronounced curved channel running North South along R410 for about 1.5 km. The surrounding area is reported to have extensive deltaic deposits and an abundance of glacial sediment. The formation of this glacial spillway is probably due to flowing meltwater from a glacially dammed lake during Quaternary.

Site Importance: - This is one of a range of such glacial spillways abundant in West Wicklow but represents a good example in Kildare and should be listed as a County Geological Site.

Source of Information Geological Survey Ireland, Why let this be at risk of damage.

Now the storage of Fuel and Chemicals:-
