My name is June Brogan, from Trammon, Rathmolyon, Co.Meath A83 TW74.

I wish to lodge an objection to An Bord Pleanala regarding the submission by Keegan Quarries in Tromman (reference SU17.319397)on March 20th 2024 for Substitute Consent for Quarry and Ancillary Precast Concrete Manufacturing Yard.

As I am the closest house to this quarry I have many concerns that this quarry is operating in breach of planning as current planning expired in August 2018. We have issues with noise pollution and worries about the structure of our property from constant blasting. We have concerns for our well water which has ran dry three times in the last couple of years. We also worry how close the quarry is to our property now. It is our opinion the Keegan Quarries have a blatant disregard for the guidelines in which the quarry was granted and operated beyond the rules with operating times and boundaries. A detailed investigation into this oeration needs to happen and he must be held accountable for his actions Kind Regards.
