I refer to correspondence received by the Agency from consultants on behalf of Enva Ireland Ltd, dated 11<sup>th</sup> April 2024 regarding the planning application and Environmental Impact Assessment Report (EIAR) for the above referenced development. The Agency makes the below observations.

Enva Ireland Ltd was issued a Waste Licence (Register No: W0192-03) on 22 July 2010 for a facility located at Block 402, Grant Drive, Greenogue Business Park, Rathcoole, Dublin. The location of the facility appears to be the same location as the proposed development. In accordance with the 2013 amendment of the EPA Act and Waste Management Act and to give effect to the Industrial Emissions Directive, the licence W0192-03 was amended on 7<sup>th</sup> January 2014 to incorporate the requirements of an Industrial Emissions Licence. The activities licenced are listed below.

The first licence for the waste facility (Register W0192-01) was issued to Rilta Limited t/a Sita Environmental on 2<sup>nd</sup> December 2004. The current licence Register W0192-03 was transferred to Enva Ireland Limited on 30<sup>th</sup> January 2024.

Please note that the licence application for Licence Register No. W0192-02 was accompanied by an Environmental Impact Statement (EIS). Details of the licence applications, EIS, licences and any amendments made to the licences for this facility may be viewed on the Agency's website <a href="https://www.epa.ie">www.epa.ie</a>. The current licence Register No. W0192-03 may need to be reviewed or amended to accommodate the changes proposed in the planning application.

It is noted that the planning application was accompanied by an EIAR. As part of its consideration of any licence review application that may be received which addresses the changes proposed, the Agency shall ensure that before the revised licence is granted, the licence application will be made subject to an Environmental Impact Assessment as respects the matters that come within the functions of the Agency and in accordance with Section 83(2A) and Section 87(1G)(a) of the EPA Act. In addition, consultation on the licence application and EIAR will be carried out in accordance with Section 87 (1B) to (1H) of the EPA Act as appropriate. Please also

note that you will be requested to provide the documentation relating to the EIA you have carried out to the Agency under Section 173A(4) of the Planning and Development Act 2000 as amended.

Should a licence review application be received by the Agency, all matters to do with emissions to the environment from the activities proposed, the licence review application documentation and EIAR will be considered and assessed by the Agency.

Where the Agency is of the opinion that the activities, as proposed, cannot be carried on, or cannot be effectively regulated under a licence then the Agency cannot grant a licence for such an activity. Should the Agency decide to grant a licence in respect of the activity, as proposed, it will incorporate conditions that will ensure that appropriate National and EU standards are applied, and that Best Available Techniques (BAT) will be used in the carrying on of the activities.

Finally, please note that in accordance with Section 87(1D)(d) of the EPA Act, the Agency cannot issue a Proposed Determination on a licence application which addresses the development above until a planning decision has been made.
