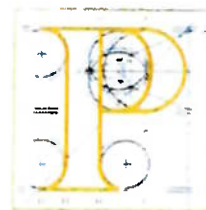



We wish to express our support for this very welcome development in the Tarbert Ballylongford landbank which was purchased by the State to promote heavy industry by using the natural advantage of the Shannon Estuary deep water.

The Climate Action Plan requires the development of 2,000 MW of gas fired electrical generation capacity to keep the lights on.

The Governments attempt to encourage more electricity generation through recent capacity auctions have been very disappointing, and even successful bidders have withdrawn. The recent EPA report found that the Government is unlikely to meet hardly any of their targets for emission reduction.

The Developers in this case have spent a lot of money and time and been very persistent, despite the active opposition of the Minister to their previous plans.

This proposed power plant on the landbank will provide 600 MW of what the Government's Climate Action Plan requires.

We strongly urge An Bord Pleanála to grant planning permission for this project without delay.

We note the Shannon Estuary Taskforce report from July 2023 which strongly supports energy based developments on the landbank.
