Re: Section 37E of the Planning and Development Act 2000, as amended – Planning Application to An Bord Pleanála for a Proposed Wind Farm Repowering Application of the existing Kilgarvan Wind Farm, in the townlands of Inchincoosh, Inchee, Lettercannon, Coomacullen and Cloonkeen, Co. Kerry

Dear Sir / Madam,

It is the observation of the Irish Aviation Authority that the applicant should be required to engage with Kerry Airport and the air navigation service provider (ANSP) Air Nav Ireland to confirm that the proposed wind turbines and the associated cranes that would be utilised during construction are reviewed for any potential impact on instrument flight procedures at Kerry Airport and en-route communication, navigation and surveillance equipment.

In the event of planning consent being granted, the applicant should be conditioned to contact the Irish Aviation Authority to:

- (1) agree an aeronautical obstacle warning light scheme for the wind farm development,
- (2) provide as-constructed coordinates in WGS-84 format together with ground and tip height elevations at each wind turbine location and:
- (3) notify the Authority and Kerry Airport of the intention to commence crane operations with a minimum of 30 days prior notification of their erection.
