NOTICE OF APPLICATION FOR APPROVAL TO AN BORD PLEANÁLA, SECTION 177AE OF THE  
PLANNING & DEVELOPMENT ACT 2000 (AS AMENDED).

**Re: Construction of a water-based Activity Facility consisting of showers, changing cubicles, toilets and storage spaces, including a new wastewater treatment facility at Magherabeg Beach, Castlegregory, Co. Kerry**

Pursuant to Section 177AE of the Planning & Development Act 2000 (as amended), and the requirements of the Planning & Development Regulations 2001 (as amended), we hereby give notice that an application, including a Natura Impact Statement (NIS) and relevant plans and particulars, for a proposed development comprising the Construction of a water-based Activity Facility consisting of showers, changing cubicles, toilets and storage spaces including a new wastewater treatment facility at Magherabeg Beach, Castlegregory, Co. Kerry will be submitted to An Bord Pleanála.

The Natura Impact Statement, including the plans and particulars for the proposed development, will be placed on public display from **Wednesday 5<sup>th</sup> June to Friday 19<sup>th</sup> July 2024**.

Submissions or observations with respect to the proposed development may be made to An Bord Pleanála in relation to:

1. the implications of the proposed development for proper planning and sustainable development in the area concerned;
2. the likely effects on the environment of the proposed development; and,
3. the likely significant effects of the proposed development on a European Site, if carried out.
