

Previous correspondence in respect of the DART+ Coastal North Railway Order application, reference number ABP-320164-24, refers.

In response to the error identified in the pre-application consultation file submitted with the Railway Order application on July 12th, 2024, Córas Iompair Éireann (CIÉ) now submits a full and complete version of the pre-application consultation file.

In light of this update, the period for public consultation has been extended, so all Railway Order documentation, including the updated pre-application consultation file, will remain on public display from **9th September** until **October 23rd, 2024** (six weeks from this notice of addendum).
