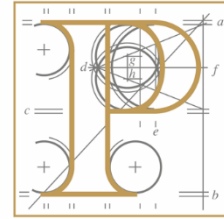

I have been asked by An Coimisiún Pleanála to refer further to the above-mentioned pre-application consultation under section 37CC of the Planning and Development Act 2000, as amended.

The application has since been made to the Commission on the 19th September 2025 (An Coimisiún Pleanála reference number: ACP-323699-25 ), the Design Opinion file is now publicly available.

A copy of the documentation relating to the Commissions Design Option Opinion and Design Flexibility Request file is enclosed for your information including a copy of the written record of the pre-application consultation meetings between An Coimisiún Pleanála and the prospective applicant.

Please note that the public will have the right to make submissions / observations on the application only to An Coimisiún Pleanála and within a time limit which will be specified in the public notices (copies of same will accompany the application documentation) and the public should be alerted to this fact when inspecting the file. It is the Commissions intention that all of the application documentation will remain available for public inspection during the currency of the application.
