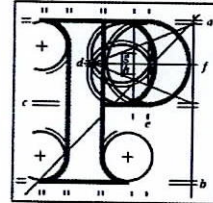

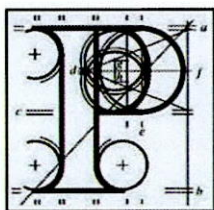

I wish to object to the proposed windfarm on a number of grounds, including,

- The height of the proposed turbines. The proposed wind turbines are 185m tall and if erected will dominate the local landscape and skyline. The noise and light pollution emitted from this proposed development will have a detrimental impact on the now quiet community where street lights are limited to the local villages.
- The proximity of the turbines to family homes. The proposed wind turbines will be extremely close to private dwelling houses and will have a major negative impact on our day-to-day lives. For some residents, they will be completely surrounded by the proposed wind farm. Additionally, for a significant proportion of the community, their views to the Hill of Uisneach, a local heritage site, will be severely compromised. This proposed wind farm will have a detrimental impact on the amenity value of the area and to the value of local houses and properties.
- The impact this proposed wind farm will have on local wildlife such as birds and bats. The removal of forestry and hedgerows will have a negative impact on the local wildlife, farming community and environment.
- The lack of community engagement. The proposers of this potential wind farm have not involved the local community and this lack of

inclusion and utter disregard for our community is totally unacceptable.

The proposed wind farm also ignores the County Development Plan.

- The potential for an extension of this proposed windfarm. Some landowners have already been approached about the possibility of extending this proposed wind farm to their lands. This means that what is proposed in this application may end up being a much larger industrial-sized development, and again a discussion in which the local community have not been included.
- The disruption caused by 31km grid connection cabling. This will negatively impact the local community, home owners along the route, wildlife and the environment. This disruption will not only cause mental and emotional stress to local residents but will also bring with it health risks.
- The volume of roadways, concrete and steel to be imported onto the sites of these proposed wind turbines. The local road network is not built to accommodate the large quantity of commercial vehicles that would be used in the development of this proposed wind farm. In addition to this, the volume of traffic would cause severe stress, risk and total disruption to the local community.
- The potential for solar energy. Solar energy is a viable alternative and has less of an environmental impact than what is being proposed in this potential wind farm. Additionally, solar energy has the potential to evenly distribute the burden of producing renewable electricity on the whole population of Ireland rather than on small, rural, local communities and villages.
- The impact this proposed wind farm will have on the development of future family homes. This proposed project will deter people who have been born and raised in the local area from building and settling in their

community, discouraging them from living beside relatives and long-standing friends and as a result, driving them out of their local community. This proposed development will erode our local community.

- MKO's history in Meenbog, Co. Donegal and the ghost wind farm in Cleanrath, Co. Cork. The reputation of this company does not portray one which values local, rural communities, environment and wildlife. In 2021, the Advertising Standards Authority of Ireland found that the developer of the proposed wind farm distributed an information leaflet locally which contained misleading and inaccurate information in relation to human health and house prices. This is unacceptable and further questions the reputation of the developer.
- The sale of windfarms to multinational companies. It is awful to think that we and our environment and wildlife will be impacted so greatly by the actions of those external to our community and who will not feel the negative effects caused by such a development.
