




I am writing to submit an observation on the above listed Strategic infrastructure development as my partner & I believe it will have a negative impact on our home & living situation. I have outlined below various reasons as to why this development will have a drastic impact on our lives. I ask that An Bord Pleanála please take our concerns into consideration in relation to this development.

Our home was not listed on any of the initial maps published by Enerco Energy, once I pointed it out to one of their representatives in June of 2022 it has started to appear on some maps but not all. There are still maps listed on their website that do not include our home please see in the attached our home should be listed beside number 5 but it is not. We feel that this is unfair representation as our home is here & should be listed on all maps anything else paints an unjust representation of the area.





The location of the development is extremely close to our home with 6 turbines to the south
of us & 3 turbines to the west of us we are literally surrounded. Given our unique proximity
to all of the turbines we feel that our location is impacted heavily by this new development.





 We are also greatly concerned on the impact this development will have on the main living area of our home as 5 of the proposed turbines are positioned on low land fields & will be in a direct line of sight from the kitchen/dining room area. These towering 185m high structures will also dominate the local landscape & skyline. Our once pleasant view of green fields & open farmland will be no more.

in the future. Given that as a risk this significantly reduces the suitability of our current home being a long-term family home. Also, Bronagh works nightshifts as a nurse, shadow flicker will make daytime sleeping much more difficult in our home.

- As our home falls within the 750m buffer zone we are concerned about the noise pollution all 9 turbines will create. As the turbines run based off wind there is no predictability as to when there will be high level of noise generated. We are both light sleepers who will not help this situation thus making our living situation much more difficult. The head shows we are concerned that the turbines will make this worse. There are various reports, studies & official documents supporting the claims that wind turbines pose threats to human health when living near them.
- We are also concerned that this development may impact our ability to build a suitable family home here as the turbines will most likely prevent us from obtaining planning permission to construct any further residential buildings here. Not to mention how this development will significantly reduce our lands suitability for building a long-term family.

These are the personal reasons I wish to include in our observation, I ask that they please be taken into consideration during the decision-making process on this matter.
