

Dear Sir or Madam,

My name is Joseph Sherwin, I am the owner of dwelling properties and a farm of land directly adjacent to the proposed sites of several wind turbines at issue. I attach shot of developer map with location and folio number to demonstrate. My properties and land have also been falsely stated in the referenced application as being participating properties in support of the proposed development. This is manifestly false and apparently this has been brought to your attention and corrected by the developer although I do not see evidence of this. My properties and farm will be permanently devalued and disrupted by the erection of this volume of large scale wind turbines. The nature and tranquility of the wider region will also be permanently impaired and all for a few people to profit significantly. While the negative environmental impact does not require much investigation to confirm. Any environmental benefit of such large scale development considering all wider impacts and alternatives in such a natural rural area is also obviously far from substantiated.

I am vociferously opposed to this and was delayed in making this observation having been consulted by the developer on several occasions over many years offering me money to support the application, informed that I would be kept up to date, then falsely represented in the application as being a "participating property" and trying to get to the bottom of that. Not being an environmental or planning expert it took considerable time to do that. My property is apparently house 10 however this is 1 dwelling property, there are other currently unoccupied properties and my farm of land of approximately 26.5 hectares which is closer to the proposed wind turbines. All of this is very upsetting and in my view to materially misrepresent my position, very underhand. Based on this misrepresentation I have agreed to accept all the stated impacts including light flickering etc but I absolutely have not and never did. This is very very wrong.

I reserve all legal rights to defend my home and farm from such proposed permanent devaluation and impairment and please ensure that the application is corrected to confirm that my property is absolutely not participating or supportive of this proposed development. Such manifest errors, falsely misrepresenting material facts suggest the entirety of the application should be considered in this context.
