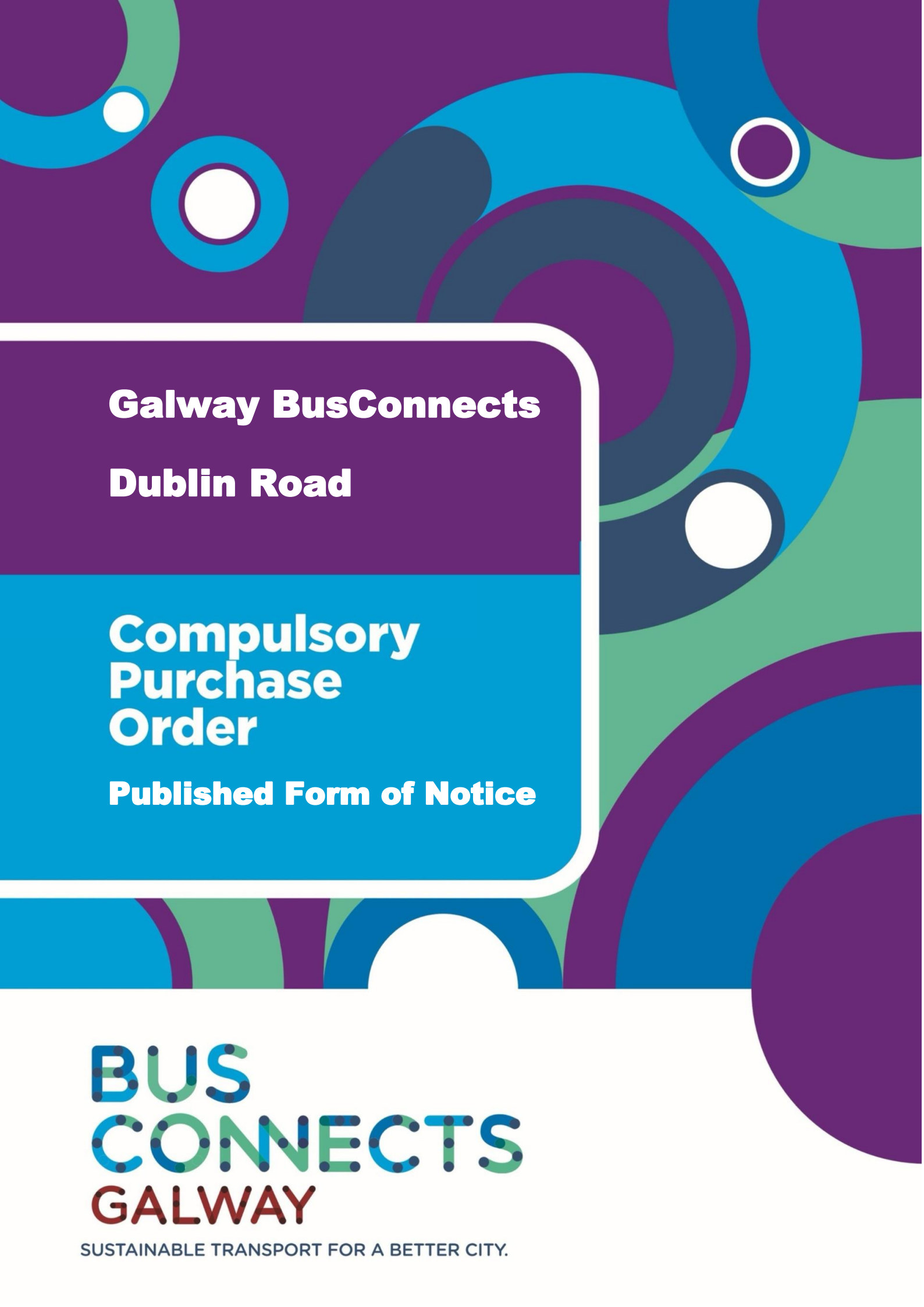

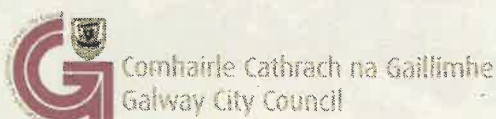

The City Council of the City of Galway (hereinafter referred to as "the local authority" (GCC) has applied under Section 51(2) of the Roads Act 1993 (as amended) to An Bord Pleanála ('the Board') for approval in relation to a proposed road development consisting of: **The BusConnects Galway**: Dublin Road Development which has an overall combined length of approximately 3.9km, and is routed along the existing Dublin Road within the County of Galway and within the Galway City Council (GCC) administrative area, inter alia:

- 3.9 km (two-way) of bus priority infrastructure and traffic management;
- 3.9 km (two-way) of street infrastructure and traffic management;
- 3.9 km (total both directions) of cycling infrastructure;
- Provision of new/refurbished pedestrian facilities and footpaths along the development and associated ancillary works;
- Provision of 9 new/amended traffic signal controlled junctions incorporating controlled pedestrian crossings;
- Provision of 9 new/refurbished continuous pedestrian and cycle crossings at accesses;
- Reconfiguration of existing and new bus stops resulting in 21 number bus stop facilities;
- Public Realm works including landscaping, planting, street furniture, street lighting, retaining walls, boundary walls and sustainable urban drainage (SUDs) measures;
- Roads associated earthworks including excavation of unacceptable material, importation of material, temporary storage of materials;
- Provision of road pavement, signing, lining and ancillary works;
- Provision of gates, fencing and boundary treatment works;
- Provision of new and diverted drainage infrastructure including two attenuation tanks and two pumping stations;
- Diversion of utilities and services including associated ancillary works; and
- Construction of accommodation works including boundary treatment and ancillary grading and landscaping works;

together with all ancillary and consequential works associated therewith.

The BusConnects Galway: Dublin Road Development will begin at east of Moneenageisha Junction and proceed along the R338 Dublin Road with junctions at Renmore Park, Renmore Road, Michael Collins Road, Ballyloughane Road, Skerritt Junction, Merlin Park Hospital, Lios an Uisce (Galway Crystal), Rosshill Road, Coast Road and Doughiska Road. The development terminates with a tie into the existing road immediately east of Doughiska Road Junction.

The location of the proposed road development is illustrated in the accompanying map.

The local authority has submitted to the Board the Environmental Impact Assessment Report prepared in accordance with Section 50 of the Roads Act 1993 (as amended) and Directive 2011/92/EU of the European Parliament and of the Council of the 13th December 2011 on the assessment of the effects of certain public and private projects on the environment as amended by Directive 2014/52/EU of the European Parliament and of the Council of the 16th April 2014 in respect of the proposed road development.

A Natura Impact Statement has also been prepared and has been submitted to the Board in respect of the proposed road development under Part XAB of the Planning and Development Act 2000 (as amended).

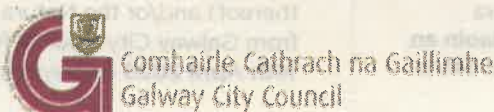

The City Council of the City of Galway (hereinafter referred to as **"the local authority"**), who, pursuant to section 10 of the Local Government (No. 2) Act, 1960, as substituted by section 86 of the Housing Act, 1966 as amended by section 6 and the Second Schedule to the Roads Act, 1993 (as amended) and section 76 of the Housing Act 1966 and the Third Schedule thereto, the Planning and Development Act, 2000 (as amended), and section 184 of the Local Government Act 2001 (as amended), have made an order titled as above which is about to be submitted to An Bord Pleanála for confirmation. If confirmed, the order will authorise the local authority to:

- acquire compulsorily the land and/or rights described in the Part I, Part II and Part IV (Section A) of the Schedule for the purposes of the construction of the BusConnects Galway: Dublin Road Development which has an overall combined length of approximately 3.9km, and is routed along the existing Dublin Road within the County of Galway and within the Galway City Council administrative area;
- extinguish the public rights described in the Part III (Section A) of the Schedule, by order made by them after they have acquired the land, where the said public rights are over the land so acquired or any part thereof, or over land adjacent to or associated with the land so acquired or any part thereof;
- restrict or otherwise interfere with the public rights described in Part III (Section B) of the Schedule;

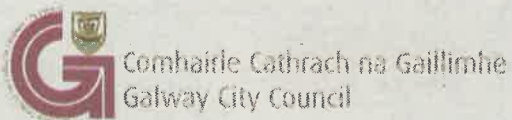
