

The submission by Galway County Council is acknowledged and some of the amendments are welcomed. Given the nature of the business and the day to day activity, there needs to be clarity around a number of further issues in order to allow the Hotel to continue to function as a commercial entity. These would be as follows:-

- 1. A clear schedule of works needs to be produced in advance of any agreement, together with an agreed time frame for works.
- 2. As the Hotel already has a large number of advance bookings, every effort must be made to try to accommodate the works during the off-season in order to minimise the losses. This would be during November/December/January.
- 3. The temporary access onto the Dublin Road during the period in which works take place at the current entrance to the Hotel, need to be clearly outlined and defined in advance.
- 4. Before the existing wall is removed, the new boundary walls must be built and all internal spaces re-instated to as close to original condition as is feasible.
- 5. Also before the removal of the existing wall, all landscaping must be completed and signage replaced, like for like.
- 6. No work materials, or equipment, are to be left on site overnight.
- 7. Given the nature/material of the existing marble picnic tables on the concrete plinth, every effort is to be made to retain these in optimal condition.
- 8. The hours of operation of works are to be agreed in advance with the management of the Hotel.
- 9. A full yellow box to be completed at the Hotel entrance.
- 10. Existing planting inside the current structure is to transferred to new beds if at all feasible.
- 11. As many of the 40 year old mature trees to be saved as possible.
- 12. Alternative coach parking to be provided and available to the Hotel for the duration o the temporary works.
- 13. The lighting on either side of the current entrance to be re-instated on completion of works.
