

Corrib Causeway - Redevelopment of Dyke Road Car Park site, Galway.

To whom it concerns,

I am writing to you from Artspace Studios on behalf of the artists and arts workers involved in our organisation, many of whom occupy studio spaces in the Black Box Theatre, which is located on the proposed Dyke Road redevelopment site. The proposed development would have a strong negative impact on the sustainability of the cultural and creative development of the area, causing the loss of workspaces for artists and depletion of tourism activities in a city known for its artistic prowess.

Artspace Studios is reaching its 40th anniversary in 2026. We have been long-term providers of high-quality, affordable studio spaces in Galway, supporting artists and arts workers with thanks to the Galway City Council Arts Office and the Arts Council of Ireland. In 1997 while Minister for Arts, Culture and the Gaeltacht, Michael D. Higgins named the Black Box Theatre a "home for Artspace Studios".

The Black Box Theatre, with its adjoining studios, plays a crucial role in sustaining Galway's cultural and creative life. Considering the immediate impact of site redevelopment, large-scale construction beside the studios

will have several negative effects, including constant noise disruption/pollution that will interfere with the ability to concentrate on work or work at all; access issues that include parking availability for the artists; health and safety in relation to air quality, as construction debris will linger and the artists will have to work in close proximity; reduced natural light from the building itself or construction machinery, as well as potential utility disruptions on essential services such as water, electricity, and internet will cause issues for the artists in creating their work; interruptions of studio visits with curators or other arts workers, which are vital for artists to be able to promote their work and sustain their practice. These reasons amongst others such as psychological stress due to uncertainty in their work environment, potentially being forced out of their studio if the construction leads to intolerable conditions, or delays/pressures due to future redevelopment changes will have a major impact on the artists' careers and cultural landscape of the area.

There is a strong artistic community in Galway. However, there is a significant shortage of artist workspaces. Removing one of the few remaining hubs for artistic production would force artists to leave the city and risk ceasing their practice. Artspace Studios has supported hundreds of artists since its establishment, and we aim to continue doing so. We cannot continue our work in providing affordable spaces for artists to engage in creating and collaborating if cultural infrastructure is demolished. The potential displacement of artists and arts workers would be devastating to the cultural fabric of the city.

It is acknowledged that in later phases of the proposal an area for civic, commercial, and cultural development has been potentially allocated. We

believe it is imperative that the local art community is involved in these decisions, and that the artists' place in the city is not an afterthought. We have spoken to representatives of the Land Development Agency at the public consultations and have expressed interest in meeting with the LDA and Galway City Council but are yet to be contacted for further discussion. This is extremely disappointing considering the proposed development would seriously compromise our ability to work.

The need for housing is urgent and must be addressed effectively. This should not come at the cost of erasing vital cultural infrastructure and displacing the artists and arts workers who contribute so wholly to the vibrancy and identity of Galway city. The redevelopment of this site would not only affect artists' livelihoods but also have much broader social and economic impacts. Galway's reputation is centred around creativity. Many students at the University of Galway and Atlantic Technological University elect to study art, theatre, creative writing, and more creative disciplines. They need spaces like artist studios and the Black Box Theatre in the city to inspire a future for their careers here. Tourists flock to Galway city to experience the creative energy and nurturing that the art community has established and works diligently to maintain. Redevelopment without a commitment to preserving cultural infrastructure will diminish the city's creative nature and impact sustainable cultural and tourism development. Housing may bring more people into the city, but the loss of cultural amenities and artists' workspaces will ensure a lack of engaging creative experiences.

Our cultural infrastructure must be protected and viewed as integral to sustainable development of a city. Artists' workspaces need to be

safeguarded and not pushed to the side. The redevelopment of the Dyke Road site without thorough consideration for the immediate and long-term effects on the city's cultural infrastructure would constitute a profound disruption to the livelihoods of the artists and arts workers based out of the Black Box Theatre, as well as deeply affecting meaningful experiences of those living in a city.

The cultural and creative vitality of Galway cannot afford to lose artist studios; these spaces need to be treated as assets. There needs to be a solution found to ensure sustainable development and cultural preservation. Your upcoming decisions will set a precedent that either values or devalues the contributions of artists in the city and across Ireland. We urge you to earnestly consider our concerns on this serious matter.
