

Sorry for the late response, as my son broke his him early July and got caught up with that.

I've looked at the response by the developers to my concerns but it still isn't right. The survey was done over three day period in early November looking at car park usage. Why not have it done at Christmas or Race week, or Arts festival????.

Also it shows alot of bicycle racks as being main parking for the new residents, so they assume all residents, even families will all have bikes and no cars. And even friends or relatives of existing residents use that car park as a means of visiting. There is not enough adequate parking facilities around the city and this will compound the situation.

They didn't offer alternatives for parking, they just stated its long established planning practise. But these practises should be updated.

Galway city is overflowing with traffic at the best of times, and to think that no resident of this new development or people accessing the creche won't use a car is ridiculous.

Its not a viable development in the city centre. I've listed other sites in my first objection submission that would be ideal. Eg. Renmore

They also stated that adverse affects would be temporary but what's the exact time frame for the development. Could it be a year or 2 of noise and disruption?

And a pedestrian crossing would be a nightmare. Just another stop for cars with another 5 just from the traffic lights to the hospital. To cause even more chaos

In relation to my observation on the environment, they said there won't be a significant impact, which means it will still impact. And as I stated in my objection submission, the rodent problem around the city is very bad.

With regards the noise pollution. What are the residents rights if the developers breaches the guidelines during the development?.
