Hi Tony,

I forgot to mention in my email previous email that the notices also state that the documentation is available to view on the Commission's website. This is not the case.

Thank you for taking my call earlier in relation to the above referenced application and another application (ABP-322242-25 Bruree Bridge, Co. Limerick).

As discussed, the notices as published and provided to the Commission include a number of errors.

The notice refers to the project being a Strategic Infrastructure Development, which it is not. They give the incorrect reference number (ABP-318802-24) This is the reference number for another case the Commission currently has on hand.

The notice references the incorrect legislation 'sub-section 2(b) of 37F of the Planning and Development Act, 2000' as opposed to section 177AE of the Planning and Development Act.

The notice also incorrectly states that a fee of €50 is required to make submissions on the significant further information. There is no fee to make a submission.

The notice states that submissions can be made online on the Pleanála website. This is not the case. As there is no fee to make a submission on the case types the submission cannot be made through the Commission's website.

The notices to prescribed bodies include the same issues.

Revised notices should be published for the public and issued to prescribed bodies correcting these issues.

The Commission can review any draft amended notices prior to publication.

Please also be mindful that any submission period that may now fall over the Christmas period, should disregard the dates of 24th December – 1st January, including, as per section 251 of the Act.

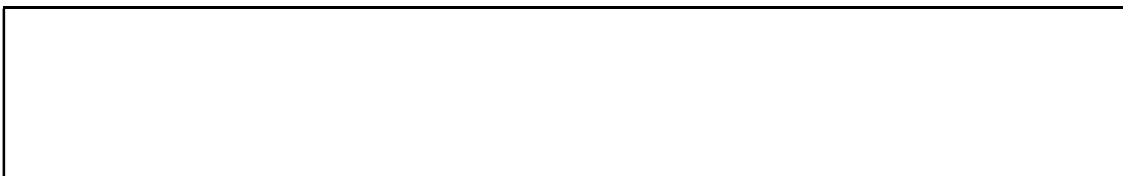
