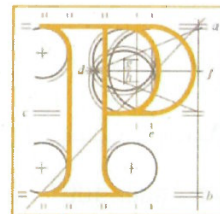

Please note when making a response/submission only to the appeal it may be emailed to appeals@pleanala.ie and there is no fee required.

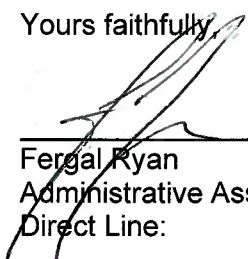
