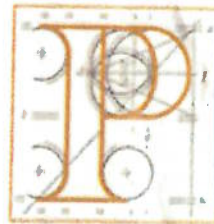

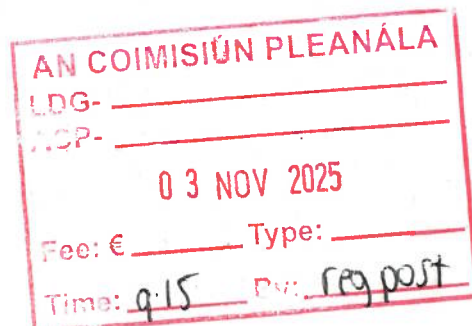

The Commission now intends to determine the above appeal before **17th February 2026**.

The Commission will take all such steps as are open to it to ensure that the appeal is determined before that date.
