I wish to appeal to An Bord Pleanála (PL04.322787) opposing the planning application 24/5503 granted to Tullacondra Green Energy Limited for the proposed wind energy facility at Tullacondra, County Cork. This objection

As a person who has devoted most of my adult life to serving the good of my community Nationally as President of Macra Na Ferma 1973-1975 and locally as a County Councillor and Cork County Mayor 2007 – 2008.

The area where the Wind Turbines are going in place are in a SAC Area. Are we to abandon everything for these out of place and wrong place for much enormous industrial machines 2.6 time Corks tallest building Cork County Hall – Cork County Council.

I would have very serious concerns for the community at large and the impact these machines will have on them and on the huge Environmental damage these machines will cause considering that the foundations for them will be thirty feet and deep considering the fragility of the rock and aquifers highlighted by the large number of Fulacht Fia's in the site. This is also a SAC area
