We wish to object and to overturn Cork County Council decision to grant planning permission for the construction operation and decommissioning of a wind energy development of nine wind turbines by Tullacondra Green Energy.

We object under the following observations.

1. We did not receive any consultation from TheTullacondra Green Energy before they submitted their application for planning permission to Cork County Council.
2. The road which will be used for the laying of approximately 13.5 kilometres of underground cable runs past our property, ' our HOME'.
3. This cable which is a 38 kilovolt cable is a high voltage hazard. It will pose a danger to those who reside in our home. This cable will be only 16/17 metres from our house. It has been noted that the closer one is to a high voltage cable the stronger the field is.

4. Magnetic fields pass easily through barriers, such as walls, buildings and the ground. This magnetic field could lead to health risks. We note that the International Agency for Research on cancer, classified electro magnetic fields as "possibly carcinogenic to humans".  
Therefore, this cable could be detrimental to our health and safety.

5. The road which runs past our home is used by:  
An Uisce Eireann. They run a 'water main' on one side of this road bringing water to Mallow town. The other side of this road is used by a 'private group water scheme' supplying water to our community. Our concern is that with the laying of this cable, water supplies may be disrupted. Water pressure which was a problem but has been resolved over the years could be further affected. This drop in water pressure if not sufficient may cause risks to the community if there should be a fire on properties, farmland and homes.
