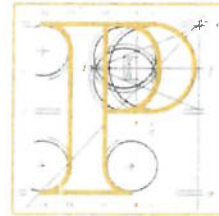

Transport Infrastructure Ireland (TII) acknowledges receipt of referral of the above application concurrent with an associated application for the proposed development of 11 wind turbines and ancillary development, An Coimisiún Pleanála case ref. PA09.322845 on behalf of the same applicant. The application states that the grid connection will loop-in connection to the existing overhead lines.

In the case of this development application, Transport Infrastructure Ireland requests that An Coimisiún Pleanála has regard to the provisions of Chapter 3 of the DoECLG *Spatial Planning and National Roads Guidelines* in the assessment and determination of the subject planning application.

TII observes that the proposed windfarm development and associated grid connection are together the "project" described in the submitted shared EIAR. In this regard, TII has noted the proposed Turbine Delivery route (TDR) includes the M4 and Junction 9 (Enfield).

TII advises it has made concurrent submission to the proposed development of 11 wind turbines and ancillary development, An Coimisiún Pleanála case ref. PA09.322845 in respect of the necessary mitigations to protect the maintenance of the safe and efficient operation of the national road network arising as a result of proposed TDR routing and associated works that will impact the M4.
