On behalf of our client, North Kildare Wind Farm Limited, (the Applicant), we are contacting you regarding An Coimisiún Pleanála's (ACP) correspondence dated 2nd April 2026, requesting that North Kildare Wind Farm Limited submit further information in respect of the Strategic Infrastructure Development (SID) application for the Drehid Wind Farm and Substation.
