Upon review of Compulsory Purchase Order (No. 3) 2025 N59 Oughterard Footbridge by Galway County Council, we have noted our findings and are presenting our objections to Compulsory Purchase Order (No. 3) 2025 on the basis of the following findings.

Galway County Council plan to acquire lands at Carrowmanagh Park by CPO for the purpose of compensatory planting of approximately forty trees, to offset tree felling outside of Carrowmanagh Park as part of the Oughterard Footbridge project.

There is also a plan to install an access gate from the Carrowmanagh Park Green to the Owenriff Riverwalk.

While I have no objection to the footbridge, I do object to the excessive number of trees that are planned to be planted on the open green area of Carrowmanagh Park, and where they are to be planted.
