Re: Athlone Link Road Phase 2

Dear Secretary,

Westmeath County Council wishes to make an application for approval to An Coimisiún Pleanála under Section 177(AE) of the Planning and Development Act 2000 (as amended) (Local Authority development requiring Appropriate Assessment) to construct a proposed road development comprising inter alia:-

- New Link Road with Active Travel facilities including segregated cycling facilities joining the Crescent Junction (R915) to Coosan Point Road/Southern Station Road Junction.
- New two-way segregated facility on Southern Station Road (West side),
- A three-metre-wide shared surface from the Crescent Junction linking to Athlone Train/Bus Station.
- A reconfiguration of, and an extension to, the existing Athlone Bus Éireann depot yard, boundary treatments, signage, drainage, and all associated ancillary works to be completed.

An Ecological Impact Assessment report (EcIA) and a Natura Impact Statement (NIS) have been prepared in respect of the proposed development.

An Environmental Impact Assessment (EIA) Screening Report for the proposed development has been carried out and has determined that there is no likelihood of significant effects on the environment arising from the proposed development and has determined that an Environmental Impact Assessment Report (EIAR) is not required.

Westmeath County Council has met with CIE Group, the owner of the lands through which the proposed road traverses, and they are supportive of the proposed development. Westmeath County Council has agreement in principle to acquire the lands for this Link Road subject to planning approval for the project.
