We are writing in response to your letter dated 9 July 2025 regarding the proposed compulsory acquisition of the site at Cooltederry, Portarlington, Co. Laois.

We wish to formally object to this proposed acquisition. While we are not the registered owners of the property, we are asserting a claim under **adverse possession**, having had continuous, open, and exclusive use and occupation of the land for over **thirty years**. This property has been in our family's use for that entire period, and we have treated it as our own in good faith.

We wish to highlight that the property has recently been **cleaned and painted**, and brought to a **respectable condition**, demonstrating our ongoing commitment to maintaining and caring for the site.

In relation to the timeline of notices referenced in the file by Laois County Council (dated 20 December 2023, 14 May 2024, and 29 May 2025), we must respectfully state that we did not receive these notices. They were not addressed to us, and to our knowledge, were placed on the front gate, which is located on a public pathway. As such, the notices could have been easily removed or tampered with by any member of the public, and we had no opportunity to formally respond at the time.

We are currently in the process of seeking to regularise our title to the property, and we intend to continue with improvements. We respectfully ask that the Commission consider our position carefully and allow us to pursue our legitimate and lawful claim, rather than permitting compulsory acquisition of a site that we have long regarded and maintained as part of our family heritage.
