It is proposed to raise the elevation of the local tertiary road (L-52214), at the above address. The length of road to be raised is approximately 200 metres. The maximum increase of road elevation will be of 1.0 metre above the existing road level, with natural rock armour embankment and natural stone parapet walls on each sides together with associated drainage, water services, fencing and signage upgrades all in accordance with plans lodged.
