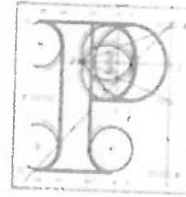

Any submissions received by the Commission will be forwarded to you for your information.



On behalf of Galway County Council, we, Langan Consulting Engineers, (LCE) hereby submit a planning application to An Coimisiún Pleanála in accordance with Section 177AE of The Planning and Development Act 2000 (as amended) and The Planning and Development Regulations 2001 (As Amended), in respect of the following development:

It is proposed to raise the elevation of the local tertiary road (L-52214), at the above address. The length of road to be raised is approximately 200 metres. The maximum increase of road elevation will be of 1.0 metre above the existing road level, with natural rock armour embankment and natural stone parapet walls on each sides together with associated drainage, water services, fencing and signage upgrades all in accordance with plans lodged.
