

It is proposed to raise the elevation of the local tertiary road (L-52214), at the above address. The

length of road to be raised is approximately 200 metres. The maximum increase of road elevation will be of 1.0 metre above the existing road level, with natural rock armour embankment and natural

stone parapet walls on each sides together with associated drainage, water services, fencing and signage upgrades all in accordance with plans lodged.

Please accept this submission in respect to the above-referenced planning application. Uisce Éireann (UÉ) has reviewed the plans and particulars submitted with the application and have the following observation(s).

Uisce Éireann's Recommendation:

No Objection in Principle

Uisce Éireann's Assessment/Observation(s):

The applicant has not included a proposal for a new water / wastewater connection in this planning application. Furthermore, it is anticipated that there will be no adverse impact on any assets or sources belonging to Uisce Éireann.

Uisce Éireann's Standard Condition(s):

The applicant shall enter into a Connection Agreement(s) with Uisce Éireann to provide for a service connection(s) to the public water supply and/or wastewater collection network and adhere to the standards and conditions set out in that agreement.

All development shall be carried out in compliance with Uisce Éireann's Standard Details and Codes of Practice.
