Mayo County Council Submission Report

Mayo County Council hereby submits the following comments in response to the general and specific points raised in the submission made by Michael G Bohan Co. Solicitors on behalf of Michael Doherty to An Coimisiún Pleanála.

General

Mayo County Council accepts that there will be an impact on the property comprising Ballina Boat Club, including temporary loss of use of the area by members of the boat club, during construction works.

I can confirm that on behalf of Mayo County Council, I met with members of Ballina Boat Club on site on 24th July 2025. This meeting was requested by the Boat Club following publication of the CPO, including erection of a site for the Boat Club property at Arbuckle Row on 15th July 2025.

At the aforementioned meeting, I provided attendees with a hardcopy of the planning drawings, which set out details of the proposed works on lands comprising plots URM1-01 and URM1-02. I explained the content of the planning drawings to all present and I dealt with queries raised on the day, in so far as information is/was available at this stage of the scheme (Stages 1 & 2). I also explained that Stage 3 (design) would address the finer points of site layout and boundary treatment. I also explained the CPO process, including the rationale for Mayo County Council taking this approach.

Leaving that site meeting, I was satisfied that all those present who engaged in a constructive manner understood the broad details of the flood scheme works in so far as these apply to Ballina Boat club lands (plots URM1-01 and URM1-02).

I also gave a commitment to all present that Mayo County Council would continue to engage with members of Balina Boat Club through the remaining stages of the flood scheme.

Specific Points raised by Michael G Bohan Co. (solicitor)

- Subject to confirmation of the CPO, Mayo County Council will serve Notice of Entry and Notice to Treat. The Local Authority will liaise with Ballina Boat Club to agree the relocation of their operations including boats and all ancillary equipment to a new temporary site. Once relocation of the Boat Club operations to a new temporary site is complete, the current site will be utilised to construct the new flood defence wall, including all associated infrastructure and it will be utilised as part of a larger compound for the flood scheme works.
- A new Slipway access from Ballina Boat Club to the River Moy estuary will be constructed as part of the Ballina Flood Relief Scheme work, to be located at the same point of the current Slipway.
 - <u>Please Note:</u> This information was provided as part of my briefing to Ballina Boat Club members, during the on-site presentation of 24th July 2025
- In relation to the provision of information to Michael Doherty, following his visit to Ballina Civic Offices, he was referred to myself (Michael O'Grady) at the Flood Risk Management Section of Mayo County Council. I made a phone call to Mr Doherty on Wednesday 30th July 2025. I went through details of the proposed (Ballina) Flood Relief Scheme, including the CPO process. I also posted out a copy of the CPO maps and schedule and Planning drawings to Mr Doherty on 30th July 2025.

Although immaterial to this process, it is factually incorrect for Mr Doherty to suggest (via Michael G Bohan Co. solicitors) that, '....he did not get any information in relation to the matter of any consequence'.

Access to lands comprising plots URM1-01 and URM1-02 during Construction works will be limited to personnel directly involved in the construction and delivery of Ballina Flood Relief Scheme.
 Ballina Boat Club will be accommodated as outlined in paragraph one above of the Specific Points raised by Michael G Bohan Co.

Dear Sirs,

We have been requested to write to you by our Client relative to your proposed acquisition via a CPO of the property coloured in grey on the map attached hereto. Our Client has stored a boat in a shed adjacent to the property you propose acquiring for in excess of 22 years without fear or favour. He believes that he is entitled to use the shed as of right and in fact may make an application to become the owner of it by way of long possession.

Our Client is concerned to ascertain as to whether or not he will have access to the shed once you complete the CPO of the property coloured in grey on the map attached hereto and start to work on it.

In addition, our Client has instructed us that there is a slipway within the property, a photograph of which is attached. He, along with others, was instrumental in constructing the slipway at his own expense approximately 10 years ago and he is concerned to ensure that access to the river is provided for in the context of the property you now propose acquiring. Will you be installing a new slipway if it's the case that the one identified on the attached photograph is proposed to be removed?

Please note that our Client did call to your Civic Offices at Arran Place, Ballina but unfortunately he did not get any information in relation to the matter of any consequence. Our Client has also instructed us that there was a meeting held on Bachelor's Walk with

Michael O'Grady, an Engineer employed by you, but unfortunately our Client was none the wiser after the meeting as to what your intentions were.

Our Client is also concerned as to how he gains access to and egress from his shed while the construction works are ongoing and furthermore as to how he gains access with his boat to the river again while you are carrying out work on the property. Our Client is an elderly man and has his boat on the river for a number of months each year. It is one of his prime pastimes and the last thing he wants at this stage of his life is to lose access to his shed and the river.

We would now be obliged if you would address the above matters as soon as possible bearing in mind that the last thing our Client wants to do is to institute proceedings in order to protect his position which we trust will not be necessary.


