Form of Compulsory Purchase Order under Section 76 of and the Third Schedule to the Housing Act 1966, as extended by Section 10 of the Local Government (No. 2) Act 1960 and amended by the Planning and Developments Acts, 2000 to 2015.

LOCAL GOVERNMENT (NO. 2) ACT, 1960 AND SECTION 213 OF THE PLANNING AND DEVELOPMENT ACTS, 2000 to 2015.

WHEREAS in pursuance of Section 10 of the Local Government (No. 2) Act, 1960 as substituted by Section 86 of the Housing Act, 1966 as amended by section 6 and the Second Schedule of the Roads Act, 1993, and Section 76 of the Housing Act 1966 and the Third Schedule thereto, and the Planning and Development Acts, 2000 to 2015 and under Section 213 of the Planning and Development Acts, 2000 to 2015 the County Council of the County of Mayo (hereinafter referred to as "the local authority") have decided to effect the acquisition of the land to which this Order relates under the Housing Act, 1966, as amended and the Planning and Development Acts, 2000 to 2015.

NOW THEREFORE it is hereby ordered that:

1. Subject to the provisions of this order, the local authority are hereby authorised:
 - a) to acquire compulsorily permanent acquisition for the purposes of the construction & maintenance of the Ballina Flood Relief Scheme, together with all ancillary works associated therewith, the land described in Part I, of the Schedule hereto which land is shown hatched in grey on the map, Drawing(s) No.MGW0290-RPS-00-XX-DR-D-CPO-001, MGW0290-RPS-00-XX-DR-D-CPO-002-01, MGW0290-RPS-00-XX-DR-D-CPO-002-02, MGW0290-RPS-00-XX-DR-D-CPO-003, MGW0290-RPS-00-XX-DR-D-CPO-004, MGW0290-RPS-00-XX-DR-D-CPO-005 and MGW0290-RPS-00-XX-DR-D-CPO-00, and marked “Mayo County Council, Ballina Flood Relief Scheme Compulsory Purchase Order, and sealed with the seal of the local authority and deposited at the offices of the local authority (hereinafter referred to as “the deposited map”),
and
 - b) to acquire compulsorily permanent wayleaves for the purposes of the construction & maintenance of the Ballina Flood Relief Scheme, together with all ancillary works associated therewith, the land described in Part II, of the Schedule hereto which land is shown hatched in yellow on the map, Drawing(s) No.MGW0290-RPS-00-XX-DR-D-CPO-001, MGW0290-RPS-00-XX-DR-D-CPO-002-01, MGW0290-RPS-00-XX-DR-D-CPO-002-02, MGW0290-RPS-00-XX-DR-D-CPO-003, MGW0290-RPS-00-XX-DR-D-CPO-004, MGW0290-RPS-00-XX-DR-D-CPO-005 and MGW0290-RPS-00-XX-DR-D-CPO-00, and marked “Mayo County Council, Ballina Flood Relief Scheme Compulsory Purchase Order, and sealed with the seal of the local authority and deposited at the offices of the local authority (hereinafter referred to as “the deposited map”),
The permanent wayleaves shall convey the right for Mayo County Council, their agents, officers, servants, workmen, contractors, licensees, invitees and any other persons authorised by Mayo County Council;
 - (i) To construct, lay, keep, operate, maintain, renew repair and inspect Flood relief works and all associated physical elements provided under section 76 of the Roads Acts, 1993 (as amended) for the prevention of flooding and such other works, services and facilities

as are necessary or expedient in relation thereto or are ancillary thereto or form part of the Flood Relief works in or under the lands specified together with the right,

- (ii) To enter, with or without vehicles, plant and machinery, upon the said land at all times for any of the said purposes.

and

- c) To acquire compulsorily the permanent right of way for the purposes of the construction & maintenance of the Ballina Flood Relief Scheme, together with all ancillary works associated therewith, the land described in Part III, of the Schedule hereto which land is shown on the map, Drawing(s) No.MGW0290-RPS-00-XX-DR-D-CPO-001, MGW0290-RPS-00-XX-DR-D-CPO-002-01, MGW0290-RPS-00-XX-DR-D-CPO-002-02, MGW0290-RPS-00-XX-DR-D-CPO-003, MGW0290-RPS-00-XX-DR-D-CPO-004, MGW0290-RPS-00-XX-DR-D-CPO-005 and MGW0290-RPS-00-XX-DR-D-CPO-00, and marked "Mayo County Council, Ballina Flood Relief Scheme Compulsory Purchase Order, and sealed with the seal of the local authority and deposited at the offices of the local authority (hereinafter referred to as "the deposited map"), The right of way shall convey the right for Mayo County Council, their agents, officers, servants, workmen, contractors, licensees, invitees and any other persons authorised by Mayo County Council to use the land specified in Part IV below to:

- (i) enter with all necessary vehicles, plant and machinery upon the said plot of land and to use the land to pass and re-pass over same for the purpose of ingress and egress to and from the public road at all times, for all purposes and by all means in connections with the use and occupation by the Local Authority, their servants or agents, workmen or contractors for the purposes of the Ballina Flood Relief Scheme.

- (ii) Such rights include the right to do anything reasonably necessary for or ancillary or incidental to the Works related to and incorporating the Ballina Flood Relief Scheme to be carried out, erected or constructed upon the lands described in Part I of this Schedule.

and

- d) to acquire compulsorily temporary acquisition for the purposes of the construction & maintenance of the Ballina Flood Relief Scheme, together with all ancillary works associated therewith, the

land described in Part IV, of the Schedule hereto which land is shown on the map, Drawing(s) No.MGW0290-RPS-00-XX-DR-D-CPO-001, MGW0290-RPS-00-XX-DR-D-CPO-002-01, MGW0290-RPS-00-XX-DR-D-CPO-002-02, MGW0290-RPS-00-XX-DR-D-CPO-003, MGW0290-RPS-00-XX-DR-D-CPO-004, MGW0290-RPS-00-XX-DR-D-CPO-005 and MGW0290-RPS-00-XX-DR-D-CPO-00, and marked “Mayo County Council, Ballina Flood Relief Scheme Compulsory Purchase Order, and sealed with the seal of the local authority and deposited at the offices of the local authority (hereinafter referred to as “the deposited map”).

2. The land described in Part I of the Schedule hereto and coloured grey on the said deposit maps, is land other than land consisting of a house, or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.
3. The land described in Part II of the Schedule hereto and coloured yellow on the said deposit maps, is land other than land consisting of a house, or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.
4. The land described in Part III of the Schedule hereto and hatched with red diagonal lines on the said deposit maps, is land other than land consisting of a house, or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.
5. The land described in Part IV of the Schedule hereto and coloured green on the said deposit maps, is land other than land consisting of a house, or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.
6. Subject to any necessary adaptation, the provisions of:
 - a) the Land Clauses Acts, (except Sections 127 to 132 of the Land Clauses Consolidation Act, 1845, and Article 20 of the Second Schedule to the Housing of the Working Classes Act, 1890), and
 - b) the Acquisition of Land (Assessment of Compensation) Act, 1919, as amended by the Acquisition of Land (Reference Committee) Act, 1925, the Property Values (Arbitrations and Appeals) Act, 1960, and the Local Government (Planning and Development) Acts, 1963 as applied by Section 265(3) of the Planning and Development Act, 2000 and as amended by Section 48 of the Planning

and Development (Strategic Infrastructure) Act 2006, as modified by the Third Schedule to the Housing Act, 1966, are hereby incorporated in this Order and the provisions of those Acts shall apply accordingly.






